NOTICE OF APPEAL

The foregoing cases were consolidated by the Supreme Court on May 8, 2014. (Exh. 1). Then-Chief Justice Toal ordered the consolidation and assigned “all matters arising out of the Coral Resorts litigation currently pending and to be filed in the state court system” to “a single circuit court judge”, the Honorable Ernest J. Kinard, Jr. *Id.* On October 6, 2014, Chief Justice Toal assigned the cases to the Honorable R. Markley Dennis, Jr. (Exh. 2). On October 22, 2014, Chief Justice Toal assigned the cases to the Honorable J. Derham Cole. (Exh. 3).

Appellants appeal the Orders of the Honorable J. Derham Cole dated (1) March 7, 2016, Form 4 order granting Defendants’ motions to strike particular allegations of the Complaint and granting Plaintiffs’ motion for discovery but ordering production in a redacted form; (2) August 31, 2016, issuing detailed orders granting Defendants’ motions to strike particular allegations of the Complaint and omitting any ruling or discussion of Plaintiffs’ motion to compel discovery; and (3) May 19, 2017, Form 4 order denying Plaintiffs’ Rule 59(e), SCRCP, motion to alter or amend.

On May 19, 2017, Appellants received notice by e-filing of the Order denying the motion to alter or amend. This Notice is timely filed. A copy of the Orders appealed from are attached to this Notice. (Exh. 4). As noted above, these cases were consolidated by the Supreme Court. The lower court issued single Form 4 orders but individual detailed orders. All of the August 31, 2016 orders are attached.

Judge Kinard shall decide all matters pertaining to these cases, and pursuant to this assignment shall set deadlines as he deems appropriate, and shall retain jurisdiction over these cases regardless of where he may be assigned to hold court and may schedule such hearing as may be necessary at any time without regard as to whether there is a term of court scheduled.
