Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Kinjta Kadeem Sadler v. The State of South Carolina in the Supreme Court on May 1, 2017. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Michael Christopher Kennedy v. The State of South Carolina in the Supreme Court on April 27, 2017. Counsel filed the brief of petitioner in the case of The State v. James Clyde Dill, Jr. in the Supreme Court on April 24, 2017.

4. Counsel makes this request in good faith and not for purpose of delay. Counsel intends to continue to work on the cases with more than three extensions first so that the caseload

will hopefully become more manageable in the near future, and less extensions will need to be requested.

5. Counsel for the Attorney General's office consents to this request shown by signature below.






