


**DISMISSAL AGREEMENT**



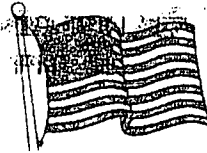
