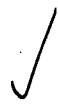

MOTION FOR SECOND EXTENSION OF TIME**





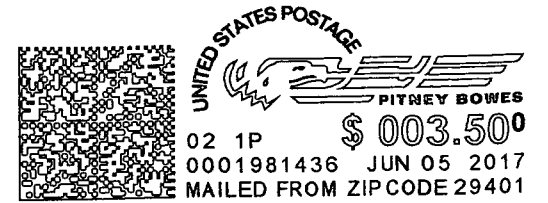
