

As was requested, please let this correspondence stand as an update concerning the Notice of Appeal for Mr. Ontavious Plumer. This office has not yet received a copy of the sentencing sheets from the Jury Trial of Mr. Plumer. The proceeding was in fact a Jury Trial and not a guilty plea. The trial took place in Greenwood County before the Honorable Edward W. Miller where the Appellant was found guilty following a jury trial the week of February 6- 8, 2017, on one (1) count Attempted Murder, one (1) count of Armed Robbery, and one (1) count Possession of a Weapon during a Violent Crime. He was sentenced to Life without Parole.

Since the time of the initial filing of the Notice of Appeal, Mr. William Nettles has been retained as counsel to perfect the appeal. Mr. Nettle's office may have received additional documents concerning this appeal that were not previously made available to Mr. Yarborough.


