Dear Ms. Kitchings:

I am in receipt of the Court's June 9, 2017 correspondence noting a deficiency with the Appellants' filing of the Record on Appeal. Specifically, one of the attorneys for the Respondent, Alan R. Belcher, Jr., who is also a member of the firm Hall Booth Smith, PC, was inadvertently left off the signature block.

I was out of the country at the time that your letter came to our office and I did not receive same until my return to work on June 19, 2017. I called the deputy clerk of court, Ms. Allen, and left a voice message inquiring as to the best manner to correct this error. From our standpoint, it seems economically and environmentally wasteful to print an entire new set of copies of the Record on Appeal due to this small error.


