ON THE ABOVE DATE AND TIME REPORTING OFFICER WAS DISPATCHED TO THE LISTED LOCATION IN REGARDS TO SUSPICIOUS ACTIVITY. REPORTING OFFICER PATROLED THE IMMEDIATE AREA AND DID NOTICE A BLACK IN COLOR SUV BEARING SOUTH CAROLINA LICENCE PLATE 564 XJL PARKED ON THE LEFT SHOULDER ON THE ROAD WITH THE FRONT PASSENGER DOOR OPEN. REPORTING OFFICER DID ADVANCE TOWARDS THE VEHICLE IN UNIT 3 AT WHICH TIME WAS ABLE TO READ THE TAG AND OBSERVE THAT THE VEHICLE APPEARED TO BE UNOCCUPIED. REPORTING OFFICER AT THIS TIME DROVE PASSED THE VEHICLE IN UNIT 3 MAKING A U TURN IN FRONT OF THE SUV. REPORTING OFFICER STEPPED OUT OF UNIT 3 TO ATTEMPT TO CLEAR THE VEHICLE WHEN AT THAT APPROXIMATE TIME REPORTING OFFICER NOTICE A BLACK MALE WEARING DARK IN COLOR PANTS AND DARK IN COLOR SHIRT RUNNING IN THE DIRECTION OF THE SUV WHERE REPORTING OFFICER WAS STANDING. SUBJECT AT THIS TIME APPARENTLY MADE VISUAL CONTACT WITH REPORTING OFFICER AND STOPPED RUNNING IN A AREA IN APPROXIMATE DISTANCE OF 50 YARDS FROM REPORTING OFFICER AND THE SUV. REPORTING OFFICER DID NOTICE THAT THE SUBJECT DID HAVE A OBJECT IN HIS RIGHT HAND THAT WAS BELIEVED TO BE A WEAPON. REPORTING OFFICER DID PRESENT SIDE ARM AND GAVE THE SUBJECT A COMMAND TO STOP AND PUT THE WEAPON DOWN. SUBJECT AT THIS TIME BEGAN TO BACK AWAY PLACING THE OBJECT BEHIND HIS LEG AND RAN BACK IN THE DIRECTION THAT HE BEGAN RUNNING FROM. REPORTING OFFICER DID NOTICE A SECOND SUBJECT THROUGH THE TREE LINE RUNNING IN THE SAME DIRECTION OF SUBJECT 1 WITH THE SAME COLOR OF CLOTHES BEFORE THE COMMAND TO STOP WAS GIVING BY REPORTING OFFICER AND SUBJECT 2 BEGAN TO RUN AWAY FROM THE INTENDED DIRECTION. REPORTING OFFICER DID NOT PURSUE ON FOOT DUE TO NOT KNOWING ALL THE DETAILS OF THE SITUATION AND HAD NOT CLEARED THE VEHICLE. UNITS WERE NOTIFIED OF DECRYPTORS AND THE LAST KNOW LOCATION OF THE SUBJECT. LEXINGTON COUNTY UNIT WHERE ALSO NOTIFIED IN THE AFFORD TO LOCATE THE SUBJECTS THAT WHERE LATER LOCATED ON ALBERT ST IN THE TOWN OF BATESBURG LEESVILLE SOUTH CAROLINA.

AFTER FURTHER INVESTIGATION REPORTING OFFICER WAS NOTIFIED THAT THE SUBJECT HAD KICKED IN THE BACK DOOR OF THE LISTED LOCATION ROBBED THE LISTED VICTIMS AT THE LISTED LOCATION AT GUN POINT AND TAKING OBJECTS OUT OF THE RESIDENCE. VICTIM 1 STATES THAT SHE AND HER FAMILY WERE LOCATION INSIDE OF THE LISTED LOCATION WHEN THREE BLACK MALE ENTERED THE RESIDENCE DEMANDING MONEY. VICTIM 1 STATES THAT ALL OF THE SUBJECT WERE WEARING DARK IN COLOR CLOTHING AND BLACK MASK AND ALL WERE IN POSITION OF A GUN. VICTIM 1 STATES THAT THE SUBJECTS TIED HER AND VICTIM 2 BY THE WRIST WITH A UNKNOWN MATERIAL AND ASSAULTED VICTIM 2 WITH A HAND GUN STRICKING HIM IN THE FACE CAUSING INJURY TO THE FACE. THE SUBJECT TOOK A LARGE WATER CONTAINER THAT HAD IN APPROXIMATE VALUE OF 1200 TO 1400 DOLLARS IN CURRENCY. VICTIM 1 ALSO HAD A GOLD IN COLOR CHAIN WITH PENDANT, AND A WATCH THAT WAS ON HER PERSON THAT WAS TAKING FROM HER THAT WAS LATER RECOVERED ON THE ONE OF THE SUBJECT BY A BATESBURG LEESVILLE POLICE OFFICER DURING THE BOOKING PROCESS. THERE WAS A MONEY ENVELOP THAT WAS ALSO RECOVERED FROM ONE OF THE SUBJECT THAT CONTAINED 6-\$20 BILLS AND THREE CUSTOMER RECEIPT FROM BANK OF AMERICA THAT WAS THE PROPERTY OF VICTIM 1. SUBJECTS THEN A THIS TIME RAN OUT OF THE BACK DOOR OF THE HOME IN THE DIRECTION OF KATHLEEN ST. VICTIM 1 DID NOTICE THE SUBJECT RUNNING BACK TOWARD HER RESIDECE ON FOOT IN THE DIRECTION OF PADGETT ST. BOTH VICTIM DID HAVE INJURY TO THERE PERSON AND VICTIM 2 DID RECEIVE MEDICAL ATTENTION FROM AMBULANCE AND LATER WENT TO THE HOSPITAL FOR FURTHER TREATMENT.
