The Board, I believe, is considered to be separate from Respondent, otherwise #22 of the SC State Constitution would have been violated.

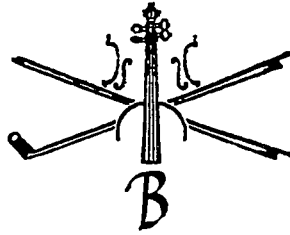

Dear Board Member,

I am the father of the Appellant.

I offer to present, in executive session, compelling evidence that Jeffrey C. Moss committed alleged perjury during a hearing held April 30, 2015 to May 2, 2015 to the Board.

Your attorneys from Childs and Halligan allegedly suborned this perjury and allegedly violated the Rules of Professional Conduct--see Rules 3.1 to 3.3.

I can present the evidence in about 25-45 minutes and I will be happy to submit to questions for as long as you wish concerning the numerous perjury exhibits. I will confine myself to Moss' sworn testimony, Moss' related emails, telephone records, and letters to and from the firm of Childs and Halligan.

If you wish I can address the issue of motive, but that will involve more time and will allude to documents still withheld by Respondent.

I attended your Board Hearing in 2015. I was shocked that your Advice Counsel and your attorneys allowed evidence and testimony that they knew to be false.

As background may I suggest that you visit the North Carolina websites (links attached) where Moss behaved, as he admitted, "unprofessionally". Moss claims to have a Ph.D. from South Carolina State University in Education Administration. SC State has never offered a Ph.D. in Education Administration, according to Elizabeth Horton, Administrative Assistant at SC State.

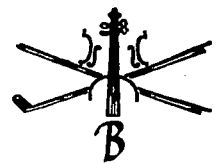
