I also have told well was asked to testify against my co-defendant if necessary. At the timing of the incidents giving rise to the indictments I was eighteen years old. While in jail, I've also completed a turning leaf program.

Following the sentence imposition, counsel for Appellant filed a Motion to reconsider sentence on June 11, 2014. R. 36. The grounds stated therein were that Appellant believe the solicitor's position regarding sentencing was represented differently on the record than had been expressed to me, which it was. R. 36. On July 8, 2014, Judge Kirdin issued her order denying the motion R. 36. Without my lawyer Jennifer Davis being notified about it, I honestly agreed to plead guilty, and cooperate with the state based upon an understanding that I would receive a sentence which was shorter than the one I received with that before my other two lawyer Ms. Jennifer Davis and Mr. Collins there were. Mr. James Cooper had specifically told me the day before I went in front of Judge Cooper that if my cooperation being laid on the table my court date will be extended after I've done what I've was willing to do as well and was ~~said~~ that my code friend had to plea and was said that more than likely I was to get the minimum of 12 years. If not 10 and that was said out of Mr. James Cooper's mouth."

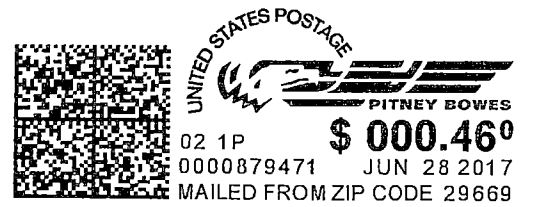
