
1. The initial brief of appellant and designation of matter are due to be filed with the Court today. This is the second extension for Mr. McCall.

State on October 22, 2012. Counsel filed the petitions for writ of certiorari and accompanying appendices in William Cornish v. State and Wiley Post James v. State on October 8, 2012. Counsel filed the petition for writ of certiorari and accompanying appendix in Archie Hoover v. State on October 4, 2012. Counsel filed the petition for writ of certiorari and accompanying appendix in Terrance Gist v. State on October 1, 2012.

4. Counsel makes this request in good faith and not for purposes of delay.
