
SECOND CONSENT MOTION TO STAY APPEAL



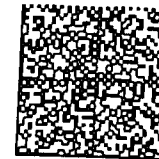
