MOTION FOR AN EXTENSION OF TIME

State of South Carolina with the Supreme Court on April 14, 2017. Counsel held an oral argument in the case of The State v. Demario Thompson in the Court of Appeals on April 11, 2017. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Tyrik Bright v. State of South Carolina with the Supreme Court on April 6, 2017. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Matthew Frazier v. State of South Carolina with the Supreme Court on March 23, 2017. Counsel filed the initial brief of appellant and designation of matter in the case of The State v. Jarvis Hughes with the Court of Appeals on March 15, 2017. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Brian Stapleton v. State of South Carolina with the Supreme Court on March 13, 2017. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Dean Henry Cole v. State of South Carolina with the Supreme Court on March 10, 2017.

4. Counsel makes this request in good faith and not for purpose of delay. Counsel intends to continue to work on the cases with more than three extensions first so that the caseload will hopefully become more manageable in the near future, and less extensions will need to be requested.

5. Counsel for the Attorney General's office consents to this request as shown by signature below.




