




LETTER OF CONSENT FOR SUBSTITUTION OF COUNSEL





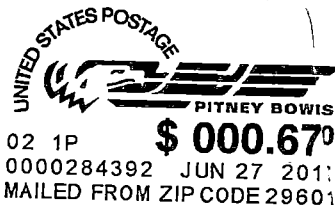
