

This is to acknowledge that on April 22, 2017, I received your letter dated April 15, 2017 requesting the Transcript of Record in the above matter. I have reviewed my records and estimate that the transcript will be approximately 25 pages.

Rule 607 provides that the rate of \$3.25 per page shall be charged. Based on this rate, the estimated cost will be \$81.25. If you desire to cancel the request for the transcript, a cancellation request must be made in writing. You will be responsible for payment of any portion of the transcript that has been completed.

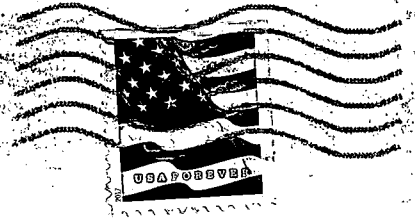
