



I testified at the Plaintiff's trial and Plaintiff was convicted in a jury trial of crack distribution in the proximity of a school and the manufacture and distribution of crack 2<sup>nd</sup> offense. 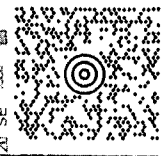
