
Court Reporter's Transcript - Update

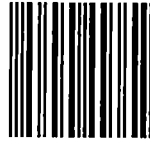
