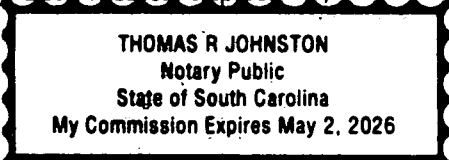

Appellant is respectfully requesting this court to reopen my my dida didmissid appeal. At present the court is al ready aware of appel lants didabilities, and the fact that that due to the lack of fiea nance, Appellant is unable to sesecure a hired helper, home nurse or any ASSISTANCE PERSONE, Therefore, being withouthelp and doing this case hard.
