MOTION TO SERVE AND FILE A SUPPLEMENTAL RECORD ON APPEAL

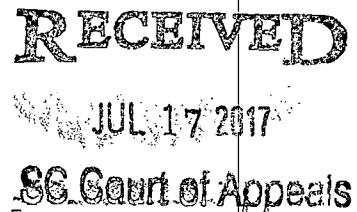
Respondent herein seeks to supplement the Record on Appeal, pursuant to Rule 210, SCACR, on the following grounds.


