**PETITION TO ORDER TRANSCRIPT

The grounds for this Petition are as follows:


1. The Notice of Appeal was filed in this matter on June 21, 2017, and the time to order the transcript expired on July 01, 2017.

2. Initially, the Appellant was planning to proceed without the transcript. However, on July 07, 2017, while preparing the Initial Brief, Appellant determined that the transcript would be support the arguments raised in his brief. Therefore, on July 07, 2017, Appellant ordered the transcript. A copy of the Letter Ordering the Transcript is enclosed as "Exhibit "A" to this Petition.
3. Appellant's initial decision not to order the transcript was simply an error in judgment, and he requests the Court to allow him to correct the error of judgment by allowing him to order the transcript out of time.
4. In the event this request is denied, Appellant requests the Court to allow him to proceed without the transcript, with the Initial Brief and Designation of Matter being due on August 21, 2017.

WHEREFORE, having provided good cause in support of this Petition, Appellant request the Court to issue an order allowing him to order the transcript out of time.




