**PETITION FOR EXTENSION TO FILE

Counsel filed the Anders brief of appellant and Record on Appeal in the case of State v. Jeremy Seldon Brady in this Court on June 14, 2017. Counsel filed the initial brief of appellant and designation of matter in the case of State v. Ronald Yates Hyatt in the Court of Appeals on June 5, 2017. Counsel filed the initial brief of appellant and designation of matter in the case of State v. Edward Chandler in the Court of Appeals on May 30, 2017.

3. This request is made in good faith, and not for purposes of delay.


4. As indicated by his consent below, counsel for the state graciously consents to or does not oppose this request.


