 RE: ACTUAL INNOCENCE - SINCE MARCH 11, 2006 - I WAS IN FLORIDA.

I KEVIN W. McDaniels, have been UNLAWFULLY INCARCERATED since March 11, 2006, for a Burglary that was committed on 1-13-06 in Spartanburg S.C. I was in Florida on JAN 13, 2006, and my INNOCENCE CLAIM has been ignored. On Aug 26, 2008, day of trial I had to change my Plea to an ALFORD PLEA (maintaining my Innocence) because Atty Robert Hall Abandoned me. I filed a PCR while in State Custody (2009), then taken into Federal Custody. Judge Dertan Cole ISSUES AN ORDER (Oct 5, 2010) stating He Refuses to entertain my PCR because I am in Federal Custody. I continuously submit Affidavits (16) from Alibi Witnesses who were in FLA with me, only to be ignored. I file Another PCR, the Court Appoints Brent Rucker (864) 271-9925. I Request he Contacts the FBI - ATF - U.S. Marshals. So they CAN Produce Evidence of me in FLA on JAN 13, 2006, he Refuses to Contact them. Evidentiary Hearing Denied. At this Present Time S.C. Appellate Defense Atty Katherine H. Huddins (803) 734-1330, has filed an Appeal in the S.C. Supreme Court - Case # 2016-001414, she has RAISED ACTUAL INNOCENCE (Filed Feb 22, 2017), But has NOT Contacted the FBI - U.S. Marshals - ATF "AS REQUESTED" so they CAN PRODUCE PHYSICAL EVIDENCE OF ME IN FLA JAN 13, 2006. I SHOULD NOT HAVE TO WAIT YEAR-AFTER-YEAR ON APPEAL PROCESS WHEN THE FEDERAL GOVERNMENT FBI - ATF U.S. MARSHALS HAVE PHYSICAL EVIDENCE OF ME IN FLORIDA ON JAN 13, 2006. I HAVE BEEN UNLAWFULLY IMPRISONED SINCE MARCH 11, 2006. MY MOTHER IS VERY SICK AND NEEDS ME HOME.

THE COURTS MADE ME WAIT SEVEN (7) YEARS TO LITIGATE BECAUSE I WAS IN FEDERAL CUSTODY. ALL MY ALIBI WITNESSES WERE PREPARED TO TESTIFY THEN AND NOW. FURTHERMORE THE FEDERAL GOVERNMENT FBI-U.S. MARSHALS-ATE CAN PROVE I WAS IN FLA. BUT SARGANBURG CO. PROSECUTORS OFFICE 'BARRY BARNETTE' (864) 596-2500. REFUSES TO ALLOW THEM TO COME FORTH WITH THIS EVIDENCE. THEREFORE I AM RESPECTFULLY ASKING THE MEDIA ETC. TO INVESTIGATE THIS MATTER. ALSO COME INTERVIEW ME HERE. MY MOTHERS HEALTH CONDITION IS VERY SERIOUS. I HAVE BEEN IN PRISON SINCE MARCH 11, 2006 (FACTUALLY INNOCENT). SEVERAL FAMILY MEMBERS HAVE PASSED AWAY. PLEASE-PLEASE I AM PLEADING FOR YOUR HELP. CONDUCTING AN INVESTIGATION ON THE SPY CO. PROSECUTORS OFFICE AND THE S.C. ATTY GENERALS OFFICE (803) 734-3737. ASKING THEM: HOW CAN THEY KEEP ME IMPRISONED EVEN AFTER THE FBI-U.S. MARSHALS ATE HAVE PHYSICAL PROOF OF ME IN FLORIDA JAN 13, 2006 - THE SAME DAY A BURGLARY TOOK PLACE IN S.C. I ENTERED AN ALFORD PLEA "MAINTAINING MY INNOCENCE" I HAVE PROVIDED THE COURTS ETC. WITH 16 AFFIDAVITS FROM ALIBI WITNESSES ALSO - FBI-U.S. MARSHALS HAVE PHYSICAL EVIDENCE OF ME IN FLA. PLEASE-PLEASE HELP ME - NO MOTHER SHOULD HAVE TO SUFFER FOR 11 YRS WITHOUT HAVING HER SON HOME TO TAKE CARE OF HER. PLEASE INTERVIEW ME - PLEASE INVESTIGATE SPY PROSECUTORS OFFICE & ATTY GENERAL. PLEASE CALL MY MOTHER AS WELL - GIVE HER HOPE. NANCY GRIFFIN 864-574-9599 (call 921-7254). I AM FACTUALLY INNOCENT. PLEASE-PLEASE HELP - THE FBI-U.S. MARSHALS ETC CAN PROVE I WAS IN FLA JAN 13, 2006 - BUT BARRY BARNETTE/ATTY GENERAL REFUSE TO ALLOW THEM TO COME FORTH WITH THIS INFORMATION.
