Today, I have faxed a copy of the receipt from the professional service of my cab driver hire to comply with Service of the recent documents to Mr. Chasteen.



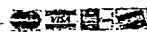
