I am in receipt of the Court's June 21, 2017 correspondence wherein the Court is notifying counsel that the time to order the transcript has expired already. The present case is an appeal arising from a Probate matter in Charleston County. The Appellants have appealed the subject case from the Probate Court to the Circuit Court, and are now appealing the Circuit Court's decision to the Court of Appeals.
