Dear Ms. Kitchings:

We are writing in response to Appellant Clarence B. Jenkins' letter dated July 18, 2017 requesting an extension of time in which to file the Record on Appeal. While Respondents do not oppose a reasonable extension of time, Respondents already have provided Appellant with the documents identified in their March 23, 2017 Motion for Correction of Record on Appeal, which this Court granted in Orders dated May 11, 2017 and July 13, 2017. The May 11 Order instructed Appellant to include in the Record "all items from both Appellant's and Respondents' designation of matter," and to correct other deficiencies identified by the Court. Respondents also note that Appellant has not submitted the required filing fee with his request.

In addition, although Appellant's July 18, 2017 letter to this Court indicates that he sent an email to Respondents, which he attached to his July 18 letter, Respondents advised Appellant approximately two years ago that they would no longer correspond with him via email. Appellant had been sending daily emails, and frequently multiple emails each day, regarding his case, complaints or his symptoms, which correspondence had become burdensome and abusive. Respondents advised Appellant that they would respond to written letters from him or motions filed with this Court but that they would no longer communicate with him via email.
