This Court is also aware by the Court's manuscript that the Judge's Order to re-mand case back to City of Brewell Court never occurred. It did not happen.

This Court is also aware that several times, Plaintiff Thomas Fuchs in case No 2016-CP-23-04998 filed in Forma Pauperis and that each time into this Court he filed in Forma Pauperis, this Court denied his request to proceed with out citing any case law to support each denial to proceed in Forma Pauperis.

In other words, there was no remedy or fundamental right within statutory exception required by constitutional provisions

of Rules of Civil Procedure Rule 3 (c).
