
This Court has recently located your notice of appeal dated March 2016, in a recent audit of our files. We sincerely apologize for the delay.

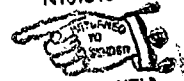
