court on June 5, 2017.


2. The lower court only granted three(3) of the Summary Judgments to Respondents.

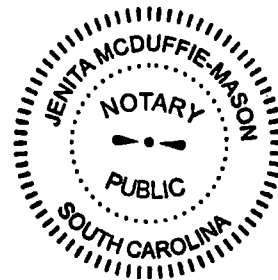



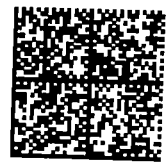
