
Dear Mr. Watkins:



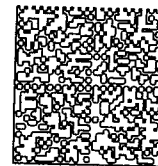
