
NOW COME Respondents, Mansour Rashtchian and Amy Rashtchian, pursuant to Rule 263(b), SCACR, as well as the Court's Order of July 16, 2014, regarding Extensions in Cases Seeking a Petition for a Writ of Certiorari to Review a Decision of the South Carolina Court of Appeals, and hereby move for an extension of ten (10) days' time to file/serve their response to the petition.

1. Petitioners served their Petition for a Writ Certiorari on July 11, 2017, making the deadline to respond August 10, 2017, pursuant to rule 242(f), SCACR.
2. 

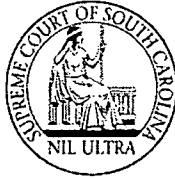
