**MOTION FOR SECOND EXTENSION OF TIME TO FILE
INITIAL BRIEF OF RESPONDENT AND
DESIGNATION OF MATTER**

The undersigned counsel would respectfully request a thirty (30) day extension in which to file the Initial Brief of Respondent in the above-referenced case. In support of this motion, counsel would respectfully show the Court the following:

Respondent's Initial Brief is due Monday, August 21, 2017, upon this Court's grant of Respondent's first request for an extension filed on July 21, 2017.

The undersigned attorney for the Respondent has had a number of state and federal matters to attend since July 18, 2017. Specifically,

1. Counsel filed the Initial Brief of Respondent in the Marlboro County appeal matter of The State vs. Tyrone Quick, Appellate Case No. 2016-00540 on July 20, 2017;

2. Counsel has participated in and has done a substantial amount of work, including preparing and filing the Respondent's Motion for Summary Judgment on August 15, 2017, in Stephen Corey Bryant, #5252 vs. State of South Carolina, Case No. 2016-CP-43-828, a Sumter County capital post-conviction relief matter;

4. Counsel filed the Motion for Summary Judgment, Return and Memorandum of Law in Support of Motion for Summary Judgment in the matter of Perry B. Buchanan, #281305 vs. Dunlap, Warden, C/A No. 4:17-1490-MGL-TER on August 7, 2017;

5. Counsel is currently preparing the Return to Petition for Writ of Certiorari in the matter of Carrie Callaham vs. State of South Carolina, Appellate Case No. 2016-001744, Lower Court Case No. 2014-CP-32-1177, a Lexington County Post-Conviction Relief appeal matter which is currently due to be filed on Wednesday, August 23, 2017; and

7. Counsel has also been reviewing matters due to her involvement in the Office of the Attorney General's Appellate Decision Review Committee.

However, due to counsel's involvement in these and other matters pending in state and federal court, counsel is unable to timely complete the Initial Brief of Respondent in this proceeding. 


