Also, in my review of the file, it appears Mr. Morgan did not comply with Appellate Court Rules, specifically the following defects:

1. There is no indication the Notice of Appeal was filed with the clerk of the lower court as required by Rule 203(d)(1)(B);
2. The copy of the Notice of Appeal received by the Respondent did not have attached a copy of the order being appealed as required by Rule 203(d)(1)(B)(ii);
3. The copy of Appellant's letter ordering the transcript of record was not served on counsel for Respondent as required by Rule 207(a)(1).

I am in receipt of Mr. Morgan's letter dated November 15, 2012. Please note Respondent does not consent to Appellant's request for an enlargement of time. Particularly, as Mr. Morgan has not advised the court what time he would like to enlarge. Mr. Morgan has had more than sufficient time to locate and obtain counsel. Appellant would move that due to these deficiencies, the appeal be dismissed.




