

NOTICE OF APPEAL

Oscar Small appeals his convictions and sentences in this case. Small was tried before the Honorable R. Ferrell Cothran, Jr., and a jury from July 24 through July 27, 2017 for the charges of Criminal Sexual Conduct with a Minor (under age 11), 1st degree, and Exposure of Another to HIV. The jury found Small guilty of both charges, and Judge Cothran imposed a sentence of twenty-five (25) years for Criminal Sexual Conduct, 1st Degree, and a consecutive sentence of ten (10) years for Exposure to HIV, for an aggregate sentence of thirty-five (35) years. This appeal follows.


