**UNOPPOSED MOTION FOR LEAVE
TO CORRECT FINAL BRIEFS**

Appellants/Cross Respondents Carla Denise Garrison and Clint Garrison request permission to revise their Final Briefs as follows:


1. All parties have filed their Initial Briefs in this case, and the record has been served.
2. The parties are in the process of preparing and filing their Final Briefs.
3. In preparing their Final Briefs, the Garrisons have realized that an unintentional factual error was included in their Initial Briefs. On page 14 of the Garrisons' Initial Appellants' brief, and on page 14 of the Initial Respondent's Brief, the following sentence appears: "Target filed a response and the Garrisons filed a rebuttal." The Garrisons did not in fact file a rebuttal in the trial court.
4. In light of this unintentional error, the Garrisons request that they be allowed to edit the sentence as follows in their Final Briefs: "Target filed a response and the Garrisons did not file a rebuttal."

5. As reflected in Exhibit A to this motion, Counsel for Respondent/Cross Appellant does not object to the Garrisons being permitted to make this change in their Final Briefs.
6. The Final Briefs currently are due on August 21, 2017.
7. The Garrisons request that both parties be given 10 days from the entry of a ruling on this motion to file their Final Briefs.

For these reasons, the Garrisons request that they be granted leave to amend their Final Briefs and that both parties be given 10 days from the entry of a ruling on this motion to file their Final Briefs.
