Your Appellant Rhonda Meisner respectfully requests the Court to allow amendment to the Record on Appeal to include the note, associated with the mortgage foreclosure action, which both U.S. Bank and Bank of America, N.A. have claimed an interest. Upon receiving the EXHIBITS from the hearing of July 10, 2014, the appellant noticed the note was not attached to the exhibits identified in the designation of matter. The mortgages in question along with the assignments of the mortgage were entered into evidence at the hearing; however, the note apparently was not included in none of the exhibits.


