
APPELLANT REPLY TO RESPONDENTS' RESPONSE TO APPELLANT REPLY AND

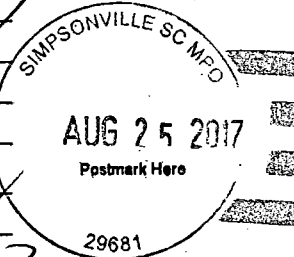

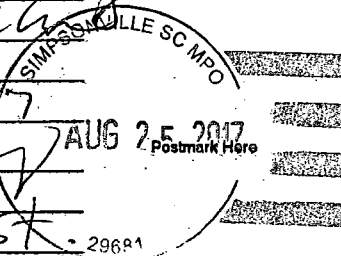


