
MEMORANDUM



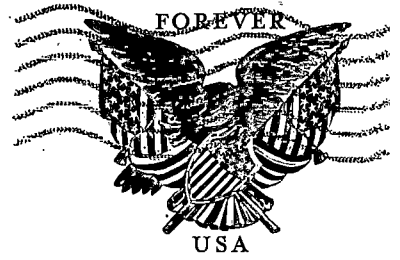
