CONSENT MOTION FOR EXTENSION





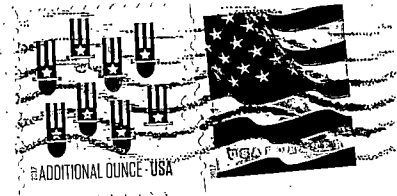
