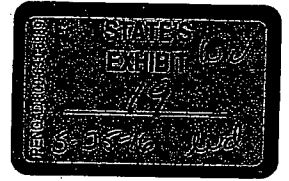

Remember My Username



You are now ready to set up *Remember My Username*. This optional feature will remember your Username for you each time you visit Web Banking from this computer. All you will need to do is select your Username from a drop down list and type in your password when signing in.

Remember My Username is intended for use at home, work, or another private computer. It should not be set up in an Internet cafe, library, or on any computer you share with people you don't know or trust.

To help you recognize your Username on the Sign In page, you may enter a nickname.

How does this computer remember my Username and nickname?

Once you click *Remember My Username*, we will attempt* to place a Username recognition cookie on this computer. If successful, Your RBC Centura Username and optional nickname will appear automatically on the Web Banking Sign In page each time you sign in from the same computer. The Username will be partially hidden. [Example: 1B****g (Pet)]

Your Username and nickname will be stored safely and securely on your computer in a small, encrypted file called a cookie.

*Note: Computer settings and/or programs may block the actual placement of the RBC Centura Username recognition cookie in which case you will be asked to provide your Username on your next sign in.

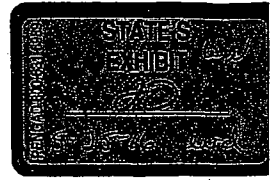


