Dear Mr. Shearouse:

On September 1, 2017, I filed a *Petition for Rehearing of Church of the Good Shepherd* with your offices. Much to my dismay, when I reviewed the Petition after the filing, I discovered that I had made a rather significant blunder in referring to the Church at various times improperly as "Shepard" but also occasionally referring to it correctly as "Shepherd". This error was not detected in the spell-check and I do regret this mistake. I have enclosed an original and six copies of a corrected petition which simply substitutes the correct word consistently throughout the Petition and I can affirm that I made no substantive edits to the document other than correcting this error. I spoke with your offices and was informed that a motion would probably not be required to correct this error of diction and I apologize to the Court for the mistake. Would it be possible to accept this substituted Petition without making a formal motion to the court?

Thank you for your consideration. Of course, I am prepared to file a motion to this effect if it is required.
