"DEAR CLERK OF COURT:

IN MY EFFORTS TO OBTAIN THE TRANSCRIPTS FOR CASE NUMBER(S) 2016-CP-43-00733 / 2017-001490 I HAVE COME TO A ROADBLOCK: MY ASSETS ARE FROZEN BY THE SUMTER FAMILY COURT (SFC), IN ORDER TO FILE MOTIONS WITH THE SFC THEY REQUIRE MOTION FEES OR IN FORMA PAUPERIS (IFP) APPROVAL. I AM ATTEMPTING TO FILE A MOTION WITH SFC BUT CAN NOT GET AN IFP AFFIDAVIT NOTARIZED AT THE PRISON BECAUSE NOTARY SERVICES NO LONGER ACCEPTS PAPER RTSM FOR APPROVAL. THE PRM IS ON LOCKDOWN AND I AM NOT PERMITTED ACCESS TO THE KIOSK. I SENT AN RTSM TO LEGAL BUT IT WAS INTERCEPTED BY SCOC AND SENT BACK TO ME WITH A NOTE ~~AND~~ TOP READING "MUST BE ENTERED ON KIOSK - PAPER REQUESTS NO LONGER ACCEPTED". TO MOTION FOR FUNDS TO PAY FOR A TRANSCRIPT
FOR A PROCEEDING HEARD IN THE COURT
OF COMMON PLEAS TO PROCEED WITH THE
APPEAL FOR THAT CASE; DENYING ME ACCESS
TO MANY COURTS.

THIS COURT IS THE ONLY COURT WHICH
HOLDS JURISDICTION OVER THE MANY.

PLEASE ADVISE."

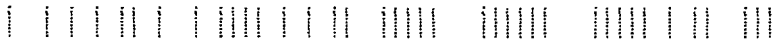
