I Kevin W. McDaniels have continuously notified the: Spartanburg County Prosecutors Office 864-596-2500 / Sptg Sheriffs Dept 864-503-4500 / South Carolina Atty General 803-734-3737 (Atty Katherine Hudgens 803-734-1330) / Atty Brandt Rucker 864-271-9925 / Judge Derham Cole 864-596-2685 / The FBI - 864-948-1497 / Supreme Court 803-734-1080 / NEWS MEDIA that I have been held Unlawfully Imprisonment Since March 11, 2006. I have provided above parties with documents by the FBI & U.S. Marshals proving I was in Florida on JAN 13, 2006 not Spartanburg S.C. when a Burglary was committed and still they conspire to keep me held false imprisonment. I demanded a trial and was coerced on Aug 26, 2008 (day of trial) to enter an ALFORD PLEA (maintaining my innocence) to a 15 yr sentence. Filed numerous appeals only to be ignored. How can any prosecutor, Sheriff, Judge or NEWS MEDIA continue to allow a factually innocent man to sit in prison since March 11, 2006 (over 11 yrs) AFTER he has presented such evidence by the FBI-U.S. Marshals proving I was in Fla JAN 13, 2006?

The Prosecutors Office Barry Barnette 864-596-2500 Refuses to allow the FBI-U.S. Marshals to produce evidence of Kevin McDaniels in Florida. I have notified the SC Supreme Court of this in the Active Appeal Case # 2016-001414, only to be ignored. I've ASK ATTY Katherine Hudgens (803-734-1330) Court Appointed Atty for Active Appeal in Supreme Court to contact the FBI-U.S. Marshals to obtain photos etc of me in Fla 1-13-2006 and present them to the Court she refuses to do so. MY family has FAXED documents to above parties and NEWS MEDIA - by the FBI proving I was in Florida - the NEWS MEDIA etc Refuses to investigate this.

How can anyone, Courts, Judges, Prosecutors, NEWS MEDIA allow an innocent person who has presented evidence by the FBI-Marshal's placing him in Florida JAN 13, 2006. Allow him to remain in prison. My Mother has suffered for 11 years, not having her son home to take care of her. She is disabled, home alone - was recently in a coma and recently lost her husband of 30 yrs, no one home to take care of her. How can ANY NEWS MEDIA etc sit back and allow a factually innocent person & his Mother to go through mental torture for 11 yrs and not act on proving his innocence so Mother and son can Reunite - Mother & son Priceless.
