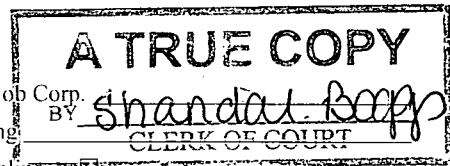



That George Anthony Clark, on or about April 22, 2016, in Abbeville County, being over the age of fourteen (14) years, the said defendant did unlawfully, willfully and lewdly commit or attempt to commit a lewd or lascivious act upon or with the body, or its parts, of a child under the age of sixteen years, to wit: D. A. J., with the intent of arousing, appealing to, or gratifying the lust or passions or sexual desires of the said defendant, or of the said child, D. A. J., in violation of Section 16-3-655(C) of the South Carolina Code of Laws, 1976, as amended.
