I Joseph Leforest Jones born the 3<sup>rd</sup> day of May 1982  
in the state of South Carolina.

I'm want to appeal my sentence of 15yrs because my Counsil  
was not effective and I believe he did not have my best interest  
in mind he just wanted a guilty plea.

Before I was cohearst into taking this plea I had ask David Hayes  
my (PD) to set up the preliminary hearing I had even wrote him  
and wrote to the Clerk of Courts to Robert J. Harte so he could make a  
copy and forward it to my (PD) David Hayes and to Request an espurgement  
sheet I also sent two letter to the SC Bar explaining the lies the  
Solicitor-Cassie Hall had told at my bond hearing were judge Early denied me.  
I had Judge Early back in (2011) for some drug charges that I wasn't guilty  
of and I ask David Hayes to get me another judge and a change of venue,  
He never did. David Hayes also didn't seem to care when I told him those  
weren't my drugs and that the Sheriff Dept must have planted them on me.  
He never check into that. David Hayes also didn't show me the videos  
when I asked every time he got the jail to bring me to the court house  
for sentencing he had always told me that the solicitors and the lawyers  
and police officer can lie. If law enforcement can lie and the people  
that takes an oath to defend us the people and that were innocent  
until proven guilty the systems wrong, I had been using drugs not  
dealing so why was I punished as a dealer I even wrote SLED explaining  
the drugs weren't mine because I had none, I was just given some people  
a ride for money and The mother of my child Stephanie Usiver was  
supposed to be in windsor, I was trying to get to my unborn child.

In June of 2016, I Explained all this to my (PO) David Hayes. I had been doing good since I was release from prison Oct, 2015.

When I got released I found out my 3 kids were taken from there mother,

I had a previous Disability Case and was going to the Doctor regularly for the bullet lodged in my spine.

I had been Calling Law Enforcement Aiken County trying to get my New Baby mother help, while trying to help get my other 3 kids a home but I couldn't find there mother.

So, The Day all this stuff happened on July 7th 2017 The officer stated that someone stuck the Bldic finger (middle finger) at him when he passed my in windsor I was parked in a yard facing the road then, All hell broke loose I didn't know that

was a police I took off trying to pull my phone off the Car Charger the phone fell in between my seats, The Car I think a blue charger kept chasing while chasing he

was sticking the middle finger looking crazy making faec, I stopped at the end of Cedar Rd. at the Stop sign he never Announced Police or anything. I told David Hayes all that, I continued at saw the Rd. Block I was to Affraid to stop

Now I had seen the police chases I was to Affraid to stop Person running Inst like they had killed People I knew in the past like the twins that Died in North Augusta on Caroling Spring Rd. I saw the accident I had just got released

hoats before and was walking to my mail box. I got to boggy gut and I think the State Trooper shot out my tire and my truck stopped then I believe that State Trooper

tried to flip my truck and pushed it into a dirt mound, I ran Affraid 2 Aiken County and pushed it into a dirt mound, I ran and started beating me in my face and I was bleeding from my left eye brow and my safety glasses I were wearing were on the ground,

While on the Grand the officers searched me and pushed my face into the dirt the more I said "I can't breathe" then they help me up cuffed and the young State trooper that had pointed to gun at me threatening to fire when I exited the vehicle was there with 3-4 other officers and they searched me again.

I felt sick and was in pain. They brought the EMS - but the EMS checked my pulse and said my pulse was better than his. In the report it stated that all 3 people that were in my vehicle were on drugs, we had done drugs earlier. 2/2

The State troopers made me sit there I kept begging for water because I became dehydrated they refused me water and medical attention I had began to pass out several times (exhaustion) Then finally - Another officer came and patted me down and escorted me to the Aik County Jail. There the Jail officer found a bag of something, I never say what it was but I noticed the bag was huge. I ask for medical while there but didn't see medical for 2-4 days later and the nurse put me on de-tox.

David Hayes my (PO) came to see me on May 3rd 2017 which was my birthday showing me videos that didn't show nothing that I was concerned with but I did notice the S.H.P.T had black out the video were the State trooper wheeled my Tahoe and the video were I was on the grand, I say the cameras running on the cars but they cut the video feed.

I told my (PO) they tampered with evidence, to get me the preliminary and he never did all he said was the solicitor had indicted me but the judge said I wasn't indicted.

S.H.P.T - State Hwy Patrol

- ① David Hayes - Didn't Spend enough time discussing my case,
- ② I was taking mental Health Meds (Cylexa) & (Vivitrol)
- ③ David Hayes - Didn't have my best interest in mind,
- ④ David Hayes - Never Filed for my preliminary hearing,
- ⑤ David Hayes - made me go in front of Judge Early knowing that he sentenced me in 2011,
- ⑥ David Hayes - said on the stand that my family was done with me on the stand in front of the Judge, making it look like know body cared,
- ⑦ David Hayes - Told me that the Government officials could lie (example) lawyers, Police, Solicitors, etc,
- ⑧ David told my mother I had 30yrs and I hadn't been to Court at the time,
- ⑨ I needed the transcript from the bond hearing and the sentencing,
- ⑩ David Hayes - Told the Judge that someone elses video that I was played in Court that Got 15yrs, that my videos were the same,
- ⑪ The Judge said maybe after the 15 years he sentenced me that I might be able to get over my Drug problems,
- ⑫ Mrs. Roxann the manager of the (PD) screened me for Rehab but David Hayes and the Solicitor had other plans,
- ⑬ I believe there was foul play on all sides,
- ⑭ I Tried to get help outside ACSO, But theres no Internal Affairs in SC that I know of,
- ⑮ The Judge Code on my sentence sheets were wrong & the Clerk of Court signatures wrong on the money part along with the Amount,
- ⑯ Judge Early Code was wrong 2011 but Grant Gibbons Played me,
