His attorney, Patricia Rivers, told him he could only go to work or school during these hours, other than that he must be home. His attorney wasn't present for the hearing to defend him. An attorney by the name of Michael Stephens was present, who knew nothing about the case. He had no case files or anything. The Appellant wasn't given any rules to abide by and he was never advised on who he must notify if he had a job. His bond was revoked because he went to work.

He now ask for this court to grant him bail while he awaits a decision. He is not a flight risk, he has lived across the street from the Chesterfield Courthouse for 41 years. The bond heard reflects this. He has never had a failure to appear. He was out on bond already a \$20,000.00 PIR bond. On all charges the police called him on the phone and he turned himself. They never had to send an officer out to get him. His bond was revoked because he was at work during curfew hours.

Relief

be granted and he be given another \$20,000.00 P/R bond, and
be allowed to work during certain hours.

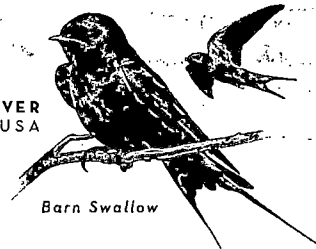
