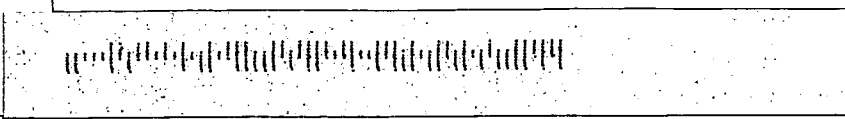
After the Death of William Spearman

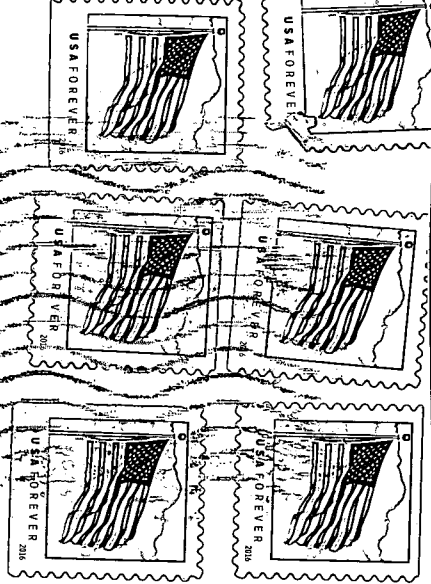
