
NOTICE OF APPEAL





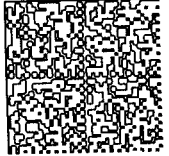
