NOTICE of Understanding And Intent And Claim of Right

- (1) whereas it is my understanding the UNITED STATES OF AMERICA is a Common Law Jurisdiction, and
- (2) whereas it is my understanding equality before the law is paramount and Mandatory, and
- (3) whereas it is my understanding a statute is defined as a legislated rule of society which has been given the force of law, and
- (4) whereas it is my understanding a society is defined as a number of people joined by mutual consent to deliberate, determine and act for a common good, and
- (5) whereas it is my understanding the only form of government recognized as lawful in the UNITED STATES OF AMERICA is a Representative one, and
- (6) where it is my understanding representation requires mutual consent, and
- (7) whereas it is my understanding that in the absence of mutual consent neither representation nor governance can exist, and
- (8) whereas it is my understanding all act are statutes, restricted in scope and applicability by the Constitution and/or Bill of Rights, and
- (9) whereas it is my understanding that said scope and applicability is limited to members and employees of government, and
- (10) whereas it is my understanding those who have SIN (Social Insurance Number) are in fact employees of the FEDERAL government and thus are bound by the statutes created by the Federal government, and
- (11) whereas it is my understanding that it is lawful to abandon one's SIN, and
- (12) whereas it is my understanding that people in the United States of America have a right to revoke or deny consent to be represented and thus governed, and
- (13) whereas it is my understanding if anyone does revoke or deny consent they exist free of government control and statutory restraints, and
- (14) whereas a freeman-on-the-land has lawfully revoked consent and does exist free of statutory restriction, obligations, limitation, and

- (15) whereas I, David A. Jones Sr am a freeman-on-the-law, and
- (16) where as it is my understanding that acting peacefully within Community standards does not break the peace, and
- (17) whereas it is my understanding that any action for which one can apply for and receive a license must itself be a fundamentally lawful action, and
- (18) whereas as I am a freeman-on-the-law who operates with full responsibility and not a child, I do not see the need to ask permission to engage in lawful and peaceful activities, especially from those who claim limited liability, and
- (19) whereas it is my understanding a by-law is defined as a rule of a corporation, and
- (20) whereas it is my understanding corporations are legal fictions and require contracts in order to claim authority or control over other parties, and
- (21) whereas it is my understanding legal fictions lack a soul and cannot exert any control over those who are thus blessed and operate with respect to that knowledge as only a fool would submit fictions to dictate one's actions, and
- (22) whereas it is my understanding that, I have a right to use my property without having to pay for the use or enjoyment of it, and
- (23) whereas it is my understanding that a summons is merely an invention to attend and that they create no obligation or dishonor if ignored, and
- (24) whereas I claim the right to collect a pension if I have paid into it and claim that said right is not affected if I abandon my social insurance number, and
- (25) whereas it is my understanding peace officers have a duty to distinguish between statutes and law and those who attempt to enforce statutes against a freeman-on-the-law are breaking the law, and
- (26) whereas I have the power to refuse intercourse or introduction with peace officer who have not observed me break the peace, and

(27) whereas government estopped by acquiescence barring any peace officer or prosecutor from bringing charges on a freeman-on-the-law under any act is created if this claim is not responded to in the second fashion and time;

Therefore be it now known to any and all concerned and affected parties, that I, David A. Curran a freeman-on-the-law do hereby state clearly, specifically and unequivocally my intent to peacefully and lawfully exist free of all statutory obligations, restrictions and maintain all rights as law to trade, exchange or barter.

(28) Furthermore, I claim the right to engage in these actions and further claim that all property held by me is held under a claim of right.

(29) Furthermore, I claim that these actions are not outside any communities standards and will in fact support said community in our desire for truth and maximum freedom.

(30) Furthermore, I claim that anyone who interferes with my lawful activities after having been served notice of this claim and who fails to properly dispute or make lawful counterclaims is breaking the law, cannot claim good faith or color of right and that such transgressions will be dealt with in a properly convened court de sure.

(31) Furthermore, I claim that the Court of the United States of America are de-facto and are in fact in the profitable business of conducting, witnessing and facilitating the transactions of security interests and I further claim they require the consent of both parties to providing any such services.

(32) Furthermore I claim the right to lawfully:

- (1) Exercise my "Common Law Right to Travel" unbounden, unencumbered, at my discretion in my private conveyance of the day, to wit, my private, unregistered, unlicensed automobile.
- (2) Exercise my "Human" Right to Travel
- (3) Exercise my "Common Law Right" to Refuse to obtain by submission: any application for any government issued license,

permit or seek permission to perform any fundamentally lawful action or, enter into any government contract under duress, threat and/or intimidation which would involve committing an act of fraud and/or theft, or any other crime, by way of deception by "I" and on any involved government principal, Employee or agent, (in compliance with my Common Law Right, Etc).

- (4) Exercise my Right to possess unregistered, unlicensed firearms and ammunition and use the same for target practice at a range or hunting for food and further swear under oath never to open fire on another human being unless as a last resort to protect human life. I claim that pursuant to any government and/or any principal, member, employee, agent, servant, person thereof in Right of The United States of America, a province, or Municipality:

"I Reserve my Right Not to be Compelled to perform under any Contract or Commercial Agreement that I did Not Enter knowingly, voluntarily and intentionally and I do Not accept the liability of the Compelled benefit of any Contract or Commercial Agreement Not Revealed to myself, which are my Right pursuant to Common Law"

- (5) Furthermore, I claim the Right to Engage in these actions and further claim that all property held by me under Common Law being: any and all Intellectual property, Real Estate, Trade Tools, private automobiles and contents, firearms and ammunition, potted plants: contents as my private dwelling are held under Claim of Right
- (6) Furthermore, I claim that the intentional blurring of the lines with smoke and mirrors, deception, with right lies and too numerous to mention false claims as to the well settled division, between the "Crown Created legal entity known as the "PERSON" and the flesh and blood creation of the Creator known as "Man" is nothing short of theft, fraud, breach of trust and forced slavery, & heinous criminal activity of the most odious form.

- (7) Furthermore, I claim that all persons, acting as government, principals, employees, agents and justice system participants claiming "Retained Legal Counsel" have by virtue of their own and/or their principals actions, claims "total incompetence" in handling any of their own affairs in law and have become an instant ward of the court, hence, they are imprisoned by their own actions in law or lack thereof.
- (8) Furthermore, I claim that due to the self evident facts in truth at hand, that all persons, the Crown, governments, principals, employees, agents and justice system participants claiming limited liability or immunity are doing so under the pretense of being in fact deemed totally incompetent and under therefore cannot claim good faith or color of right over anyone who is thus blessed as being a competent firm.
- (9) Furthermore, I claim that "ignorance of the law" is not lawful or legal claim when used by the Crown, government, principals, employees, agents and justice system participants at any and all levels to my harm or detriment, especially by those claiming limited liability.
- (10) Furthermore, I claim that all transactions of security interests require the consent of both parties and I do hereby deny consent to any transaction of a security interest issuing under any act for as herein stated as a freeman-on-the-land, I am not subject to any act.
- (11) Furthermore, I claim my "fee schedule" for my transgressions by peace officers, government principals or agents or justice system participants is "two hundred dollars per hour" or portion thereof if being questioned, interrogated, or in any way detained, harassed or otherwise regulated and two thousand per hour" or portion thereof if I am handcuffed, transported, incarcerated or subject to any adjudication process without my express written and notarized consent

- (12) Furthermore, I claim the right to use a Notary Public to secure payment of the Above mentioned "Fee Schedule" Against any Transgressor who by their actions or omissions harm me or my interests, directly or by proxy in any way.
- (13) Furthermore, I claim the right to convene a proper Court de June to address any potentially Criminal actions of any peace officer, government principals or Agents or Justice System participants who having been served notice of this claim fail to dispute or discuss or make lawful Counterclaim and then interfere by action or omission with the lawful Counterclaim and then interfere by action or omission with the lawful exercise of properly claimed and established Rights and freedoms.
- (14) Furthermore, I claim the law of agents and principal applies and that service upon one is service upon both.
- (15) Furthermore, I claim the right to deal with any Counterclaim or disputes publicly and in open form using discussion and negotiation and to capture on video tape said discussion and negotiation for whatever lawful purpose as I see fit. Affected parties ~~to~~ wishing to dispute the claims made herein or make their own Counterclaims must respond appropriately within ten (10) days of service of notice of this action. Responses must be under oath or attestation, upon full Commercial Liability and penalty of perjury and Registered in the Notary office herein provided no later than ten days from the date of original service as attested to by way of Certificate of service.

Failure to Register a dispute against the claims made herein will result in an automatic ~~and~~ default judgement and judgement and irrevocable Estoppels by Acquiescence
