REPLY TO RETURNS RE: MOTION FOR COSTS**


Appellant Daufuskie Island Utility Company, Inc. respectfully requests a 4-day extension of the deadline for filing and serving its Reply to the Returns for Motion of Costs.

The current deadline for the Appellant's Reply is September 25, 2017, but the events of Hurricane Irma have hindered Appellant's ability to prepare the Reply. Additionally, both Respondents filed separate Returns and the requested extension is necessary to properly respond to both Returns.


