Appellants John and Julie Dalen’s Motion
For Fewer Copies of The Record On Appeal


Appellants, John and Julie Dalen, hereby move for an Order reducing the required number of copies of the Record on Appeal by five copies—from fifteen plus two for the Respondents to ten plus two for the Respondents. This would be nine copies for the Court of Appeals plus one copy for the clerk, plus one copy for each of the Respondents.

This case has been in the trial court already close to six years, and it is a voluminous record. There are many documents that we would like to have included for Court review. However, we designated only what we consider the most important and relevant documents that support the issues we have raised on appeal. At this time, we estimate that the Appellants' designated matter will amount to over 400 single pages, and the Respondents' additional documents will add at least another 400 single pages. By printing double-sided copies, we calculate the number of volumes as two for each set; however, we still pay for both sides of each page. Therefore we are looking at significant expense which can be lessened by fewer total copies of sets made.


The present deadline for serving the Record on Appeal is October 23, 2017.

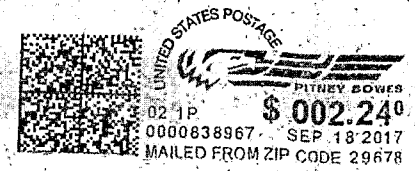
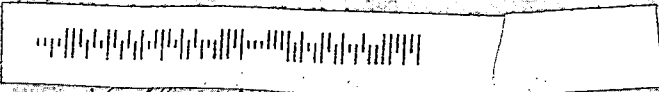
