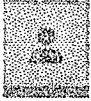

Dear Ms. Abbott Kitchings:


I am in receipt of your letter dated & mailed September 7th, 2017, which was placed in my post office box on the 13th, i.e., on yesterday's date.
